

# LICENSE AGREEMENT

**DAVID DIAL**, herein under referred to as "**DAVID DIAL, D-DIAL MUSIC or LICENSOR**" for valuable consideration and in accordance with the terms set forth below, grants **you, the individual purchaser, herein known as "LICENSEE"**, a license for the nonexclusive use of the **music and sound effects audio tracks (all or in part) contained in the audio collection known as "All The Music & Sound Effects You'll Ever Need for Your Professional Stage Hypnosis Show, 2nd Edition,"** herein referred to as "**THE MUSIC**".

All the **music and sound effects audio tracks (all or in part) included in the "All The Music & Sound Effects You'll Ever Need for Your Professional Stage Hypnosis Show" collection are licensed, NOT SOLD**, to you by **DAVID DIAL**. **DAVID DIAL** is the owner and master licensee of **THE MUSIC** and has full power and authority to enter into this agreement.

Your payment gives you, the **LICENSEE**, the perpetual, non-exclusive right to incorporate **THE MUSIC** in any musical and/or audiovisual production ("**PRODUCTION**"), such as film, television show, advertisement, website, videogame or other media production, as well as a live stage performance, without paying any additional royalties, license fees, or other fees to **DAVID DIAL**. **This license is granted for a single user only.**

**DAVID DIAL** reserves any right not expressly granted to **LICENSEE**. You own the physical disc(s) or digital .mp3 files, on which **THE MUSIC** is recorded or contained, but **DAVID DIAL** retains ownership of all music and documentation copyrights and copies of the music itself, no matter what form they are in or the media the copies reside in. **LICENSEE** assume sole responsibility for the use and results obtained from use of **THE MUSIC**.

License is granted for performance in private, commercial and business establishments; incorporation into and performance with audio, video and broadcast production.

The **LICENSEE** has the irrevocable right, license and privilege to use the recorded material for the purpose of mechanically or digitally reproducing **THE MUSIC only as an integral, synchronized part of spoken word productions**, and only on condition that **1)**, a voice is embedded over the music or SFX track **AND 2)**, there are no more than 7 (seven) seconds of music or SFX free standing in between each phrase of the voice-over.

**LICENSEE MAY NOT** distribute, sell, rent, lease, sublicense, assign or otherwise transfer any of **THE MUSIC** except as incorporated in a **PRODUCTION**. **LICENSEE MAY NOT** distribute **THE MUSIC** independently of a **PRODUCTION**, or with any directions or instructions as to how **THE MUSIC** may be extracted from a **PRODUCTION**, or with any invitation, suggestion or authorization that **THE MUSIC** may be extracted from a **PRODUCTION**. You **MAY NOT** alter or delete any "watermark" or other ordinary imperceptible identifier embedded within the **THE MUSIC**.

**LICENSEE MAY NOT** distribute **THE MUSIC**, either in native format or reformatted, filtered, re-synthesized or otherwise edited, for use as sounds, multi-sounds, samples, multi-samples,

programs or patches in a sampler, sample playback unit, website or computer. **THE MUSIC** can **NOT** be used as source playback from ROM or chip sets or embedded in any chip set.

Duplication or distribution of **THE MUSIC** by itself or as a collection, as "**All The Music & Sound Effects You'll Ever Need for Your Professional Stage Hypnosis Show**" or under any other name will violate applicable copyright laws and is subject to prosecution. **THE MUSIC CAN NOT** be resold to another user.

Placing **THE MUSIC** on the Internet is only permitted **IF 1)** a voice is embedded over the music or SFX track **AND 2)** there are no more than 7 (seven) seconds of music or SFX free standing in between each phrase of the voice-over. **THE MUSIC** may be used in a streaming audio method whereby **THE MUSIC CAN NOT BE SEPARATED** from the **PRODUCTION** itself, so as not to be used illegally by the general public.

**THE MUSIC** may **NOT** be used in any **PRODUCTIONS** that are pornographic, unethical or unpatriotic to the United States.

**NO LYRIC** or **NEW MELODY** may be added to **THE MUSIC** as a "Jingle" or "Song" without prior written permission from **DAVID DIAL**.

**LICENSEE** is not required to credit **DAVID DIAL** in your **PRODUCTION**, but I would certainly appreciate it if you do so. In which case, please indicate verbiage such as, "Music composed by **DAVID DIAL**" listing appropriate title(s), or "Additional original music by **DAVID DIAL**." **LICENSEE** may not claim the music as your own work. You may not claim ownership of the music (or otherwise make it available) through YouTube's Content ID system.

**NETWORK BROADCAST AND INTERNATIONAL BROADCAST** of this music is cleared through **ASCAP (American Society of Composers And Producers)**, whose revenues are collected directly from broadcast station licensing, and **NOT** from **YOU** as a Producer. Please indicate; "All music composed by **DAVID DIAL (ASCAP)**, and published by **D-DIAL MUSIC (ASCAP)** on your productions. Remember to list all titles individually used so that your ASCAP-affiliate broadcasters can file accurate cue sheets with ASCAP when your productions are aired.

**NOTICE: If you are submitting any of these individual tracks for inclusion on a "CUE SHEET", please omit any beginning Track Numbers or "Dancers\_" category from the "Song Title", as they are NOT part of the "SONG TITLE" (see playlists provided on the website above the audio player for the exact SONG TITLES)**

**i.e.: for "01\_Hypnotized Theme 1", enter Title as, "Hypnotized Theme 1" for "Dancers\_Belly Dancers (LONG)", enter Title as, "Belly Dancers "**

**\*DO NOT INCLUDE any PUBLIC DOMAIN SONGS to CUE SHEETS.**

# LICENSE AGREEMENT

In the event that the **LICENSEE** violates the terms of this agreement or fails to pay for the purchase of **THE MUSIC**, this license is immediately revoked. Thereafter, any use will constitute as infringement of the rights.

The **LICENSEE** agrees to hold **DAVID DIAL** and/or **D-DIAL MUSIC**, its agents, dealers, and employees free and harmless from any expenses and attorney fees that might be incurred by reason of Licensee's breach or claim of this license or any agreement between Licensee and any Third Party. The Licensee will indemnify, save, hold harmless and defend **DAVID DIAL** and/or **D-DIAL MUSIC** from and against any and all claims, demands, suits, damages, liabilities and all reasonable expenses, including attorneys' fees, against or suffered by **DAVID DIAL** and/or **D-DIAL MUSIC** in any way that could not be adequately compensated by damages. The **LICENSEE** agrees that, in the event of such improper use, **DAVID DIAL** and/or **D MUSIC** shall be entitled to an immediate injunction without the requirement of posting a bond (to the fullest extent permissible by law).

**Limitation of Liability.** **LICENSEE** agrees that the cumulative liability of **DAVID DIAL** and/or **D DAVID MUSIC**, with respect to any claims made in relation to or arising out of this agreement on any theory or basis, will not exceed the license fee paid by the **LICENSEE** for **THE MUSIC**.

## Restrictions And Limitations

**THE MUSIC** is licensed to you, not sold. The license does not transfer the copyright of my music to you.

This license expressly forbids resale, re-licensing, or other distribution of my music, either as is, or any modification thereof. You may not use, modify, resell, sub-license, assign, transfer, otherwise make available or permit access by any third party to my music, except as in cases expressly authorized by this license.

The license is not transferable. You may not re-sell or "loan" the music to others. However, your license allows usage by your client if you are contracted to create a specific final product (for example, if you are hired to produce a corporate video).

The license is not exclusive. **DAVID DIAL** retains the right to sell licenses to other clients.

All music tracks are licensed 'as is'. The total liability of **DAVID DIAL** is limited to the licensing fee paid by you to **DAVID DIAL**. You hereby agree that this license is granted to you without any other warranty or recourse and agree to indemnify **DAVID DIAL**, its owners and employees, from any damage or financial loss resulting from your usage of **THE MUSIC**.

By using any track from **THE MUSIC**, the **LICENSEE** has agreed to the terms of this license.
